The font is a bit small and compressed, but still legible, and the instructions are fairly clear, though perhaps not down to a "For Dummies" level. There are forms included in the book that you can scan, but they can be downloaded from the enodare website too (and unlock code is provided in the book). You will need the services of a Notary, but they don't charge lawyer rates. Enodare's line of self-help legal books are a great resource for those do-it-yourselfers who would rather not pay an arm and a leg for legal services for things they can do themselves. It may take a little time and concentrated reading to figure it all out, but in the end I think it's worth it. A power of attorney is a legal document that allows you appoint someone to make medical, financial and legal decisions on your behalf. Under a power of attorney, you can give your agent either general authority or limited authority. With general authority, your agent will be authorized to act as your authorized representative in relation to the whole cross-section of your legal and financial affairs. With limited authority, your agent is given authority in relation to the specific matters only - such as real estate, banking, or virtually any other matter. Both limited and general powers of attorney can also be classified as either 'ordinary' or 'durable'. Ordinary powers of attorney come to an automatic end if you become mentally incapacitated. Durable powers of attorney, on the other hand, do not come to an end when you become incapacitated (and often only commence when you become incapacitated) and should therefore form an integral part of your estate plan. It is also possible to make a healthcare power of attorney under which you can appoint someone to make medical decisions on your behalf if you are unable to do so. It also allows you direct what treatments and procedures you are willing or unwilling to accept. If you fail to make a durable power of attorney for finance and property your family may be legally helpless to manage your property and your assets. Also, by failing to make a healthcare power of attorney, you could end up receiving unwanted medical treatments.
